# **Session Brief**

For most countries, developing a well-functioning tertiary education system is critical to achieving economic and societal goals. There are many different elements to this including funding systems for teaching and research, quality assurance, continuous professional development for leaders and staff, bodies that drive equitable access and support with digital technologies There are also often bodies that represent different kinds of institutions (universities, colleges, independent HE providers) within the system and bodies that support them to develop partnerships overseas.

The UK has well-developed tertiary education systems in each of the four nations. This session, curated by the British Council, provides an opportunity to meet representatives from the various sector bodies that make up the system and to understand more about what they do and current priorities and challenges – and possibly to set the foundations for future partnerships.

## **Organisational profile**

#### **Advance HE**

## Case study

Working closely with the Ministry of Education and Science in Kazakhstan and Nazarbayev University Graduate School of Education, we delivered a series of programmes to assist sector reform. These enabled HE leaders to develop their research and entrepreneurial learning activities in line with the objectives of the State Programme of Industrial and Innovative Development as more academic freedom was granted to universities by the Ministry. In Ukraine we worked closely with the Institute of Higher Education (part of the National Academy of Educational Sciences) and the British Council we designed a multi-faceted Leadership Development Programme for 40 universities delivered over a three-year period to support the national initiative to enhance leadership capacity and support reform. Institutional change projects were undertaken in collaboration with UK institutions.

Operating under the Lisbon Recognition Convention, UK ENIC ensures international qualifications are recognised appropriately. As part of the ENIC-NARIC Networks, it supports global qualification recognition across Europe. UK ENIC plays a key role in Mutual Recognition Agreements (MRAs), which facilitate the acceptance of international qualifications between the UK and other countries. These agreements enhance trade, education, and professional mobility, ensuring qualifications are recognised both in the UK and abroad. UK ENIC leads technical discussions, supports negotiations, and drafts treaty

texts for MRAs, contributing to agreements with countries such as Argentina, Chile, Colombia, India (most recently), Mexico, and Peru. These partnerships promote international education, student mobility, and professional exchange. For professional qualifications, UK ENIC collaborates with regulatory and professional bodies to support mutual recognition under UK Free Trade Agreements (FTAs).
